Top 10 tips for buying a vehicle

1. VISUALLY INSPECT PURCHASES CAREFULLY.
2. **LISTEN TO WHAT THE AUCTIONEER SAYS!** THE DESCRIPTION GIVEN BY THE AUCTIONEER IS THE DESCRIPTION THAT FORMS PART OF THE LEGALLY BINDING CONTRACT OF SALE. DO NOT RELY UPON THE CATALOGUE OR SCREEN BANNER DESCRIPTIONS THEY ARE FOR GUIDANCE ONLY.
3. ENSURE THAT YOU HAVE **£200 CASH DEPOSIT** BEFORE BIDDING.
4. DEPOSITS CAN ONLY BE MADE BY CASH. FINAL PAYMENTS CAN BE MADE BY CASH OR DEBIT CARDS. CREDIT CARDS ARE SUBJECT TO A 3% PLUS VAT HANDLING FEE.
5. ALL PAYMENTS MUST BE COMPLETED BY 12 NOON THE FOLLOWING WORKING DAY. **LATE PAYMENT WILL RESULT IN A £25 FEE**
6. **A LEGALLY BINDING CONTRACT** IS FORMED AT THE FALL OF THE HAMMER OR WHEN A PROVISIONAL BID HAS BEEN ACCEPTED.
7. A VEHICLE THAT IS '**SOLD AS SEEN**' MEANS EXACTLY THAT! NO COMPLAINTS WHATSOEVER CAN BE ENTERTAINED.
8. A VEHICLE THAT IS SOLD '**NO MECHANICAL FAULTS**' WILL MEAN YOU HAVE 1 HOURS TRIAL AFTER FULL PAYMENT TO RAISE ANY MAJOR MECHANICAL FAULTS WITH OUR SALES TEAM. THIS DOES NOT COVER BODYWORK, TYRES, EXHAUST, LIGHTS, INTERIOR ETC.
9. **A BUYERS / SEARCH FEE IS PAYABLE ON EVERY VEHICLE PURCHASED.** THESE FEES ARE DISPLAYED IN RECEPTION AND A COPY IS AVAILABLE ON REQUEST.
10. PURCHASES ARE LEFT ON SITE ARE DONE SO ENTIRELY AT THE PURCHASERS RISK.
