

## Buying in the Classic Car Auction

### Viewing

All items may be viewed prior to the auction. Viewing will commence at 10am day on day of the sale. All other viewing is by appointment only, which you may arrange by calling us on 01244 532821.

### Catalogues

Catalogues are available to purchase on site during sale week.

### Bidding in Person:

In order to buy at our auction, you must be a registered member. You will be asked to complete a user details form and to pay the Annual Registration Fee (currently £8 INC VAT) after paying the initial registration fee, your annual membership fee is due and payable on or before 1 December each year if you wish to remain an active bidder. You will be issued with a bidding number and a membership card, you will need to produce the membership card each time you buy. (On our Specialist auctions, Police auctions and proceeds of crime auctions you will need to show your membership card on entering the premises. If you are not yet registered it is advisable to pre-register online prior to viewing) Your bidding number is not transferable and you should not allow others to use it. Raise your bidding number when you wish to bid and wait for the auctioneer to acknowledge you. If anyone else wishes to acquire the lot, they will bid against you by the same means. The auctioneer will continue taking ever-increasing bids from each interested party until all but one person drops out. The final bidder is the successful buyer and the auctioneer indicates that the lot is sold by knocking down his gavel on the rostrum and declaring the hammer price. Please note the buyer pays an additional percentage to the final hammer price. (Buyers Premium) Purchasers will require a £250 deposit payable on the fall of the hammer.

### Live Online Bidding

Live online bidding will be available for this auction via [www.easyliveauction.com](http://www.easyliveauction.com), enabling you to take part in the bidding from anywhere in the world, live as it happens.

To bid online you need to register at [www.easyliveauction.com](http://www.easyliveauction.com). In completing the bidder registration on [www.easyliveauction.com](http://www.easyliveauction.com) and providing your debit / credit card details and unless alternative arrangements are agreed with Clwyd Auction Centre, you:

- Authorise Clwyd Auction Centre, if they so wish, to charge the registered card given in part or full payment, including all fees, for items successfully purchased in the auction via [easyliveauction.com](http://easyliveauction.com), and
- 2. Confirm that you are authorised to provide these card details to Clwyd Auction Centre through [www.easyliveauction.com](http://www.easyliveauction.com) and agree that Clwyd Auction Centre are entitled to permit the shipping of the goods to the card holder name and card holder address provided in fulfilment of the sale.
- A £500 deposit is required for all online bidders. This will be refunded automatically at the end of the sale if the bid is not successful. If the bid is successful, this sum will be used towards the final bill.

N.B Once membership and online registration has been processed and authorised, the membership fee is non-refundable

### Absentee bids

These will be accepted up to close of business on the Friday before the sale. A deposit will be required in all cases. The lots will be purchased for the lowest possible price.

### Descriptions

All lots are offered with the seller's description. Any information you have seen on the web, in the catalogues or on the signs on the lots will be superseded by the auctioneer's description. All prospective purchasers should satisfy themselves to condition before bidding on any lot. All vehicles are checked on the information registers of HPI for title problems, such as finance, theft or damage related insurance claims. We ask our vendors to check where possible as to whether registration numbers are transferable – we can not guarantee, however, that the registration number of a lot is transferable, unless the vendor has specified to us that it is, so please listen to the auctioneer's description. Important – All the vehicles are sold AS SEEN, and entirely without warranty. This means there is no comeback and no rejection possibility whatsoever after purchase. It is your responsibility to ascertain the true condition of any lot before you make your bid. If you are in any doubt as to the condition, authenticity, identity or provenance of any vehicle, do not bid as there is no 'cooling off' period and no post-sale negotiations will be entered into.

### Buyer's premium & VAT

A buyer's premium at the following rates will be added to the hammer price:

For Vehicles - 10% + VAT with a minimum fee of £200+ vat

For Motorcycles 10% + VAT with a minimum fee of £100+ vat

For Automobilia and all other items 20% + VAT

### Methods of payment

Purchases will only be released when full payment (inclusive of all charges) has been made in cleared funds to Clwyd Car Auction Ltd.

We will accept payment in the following ways:

We accept payment by cash, debit card, credit card or bank transfer.

Commercial / Business cards will be subject to a 2.09% fee.

N.B. The Company accepts payments by card below £1,000, Card payments are not accepted above this amount.

(Cash is subject to a 1% handling fee). Please note that cheques are not accepted.

All goods must be paid for by 12 noon the following day.

### Removal of Lots

Failure to remove lots by the close of business on the Friday after the sale day, will result in storage charges as follows:

Vehicles £20 per day, Motorcycles £10 per day, Automobilia £1 per lot per day. All the above charges are subject to VAT.
